## **OPENING BUSINESS:**

Motion carried 3-0. At 9:45 a.m., Commissioners returned to open session with no action taken.

Larry Langerman, Dustin Neuman & Mark Bredford, Ellsworth County Fire Chiefs, requested the Commissioners to pass a resolution requiring unincorporated Ellsworth County residents to obtain burn permits. Also in attendance was Terry Kueser. These permits will insure that people will know all the rules for open burning. Residence will still be required to call their fire chiefs and the Sheriff's Office before starting the fire. Commissioner Oller made a motion to pass Resolution 18-R-03, a Resolution requiring persons to obtain a burn permit from the Ellsworth County Clerk's Office. Commissioner Dlabal seconded the motion. Motion carried 3-0. Commissioner Dlabal made a motion to accept the Fire Department rules with a change. Commissioner Oller seconded the motion. Motion carried 3-0.

# **NEW BUSINESS:**

Commissioner Oller moved to approve abatements 2017, 39 & 41 for \$549.28 and added tax 2017 43 & 44 in the amount of \$1,179.62. Commissioner Dlabal seconded the motion. Motion carried 3-0.
